AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Alderwood Water and Wastewater District from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Safeguarding of small and attractive • Payroll assets

Financial

Our opinion on the District's financial statements and compliance with federal grant program requirements is provided in a separate report issued in July 2015, which includes the District's financial statements. That report is available on our website, <u>http://portal.sao.wa.gov/ReportSearch</u>.

That report includes a finding for a material weakness in internal controls over financial reporting regarding financial statement preparation.

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal program, which is listed in the Federal Summary section of the financial statement and single audit report issued in July 2015. INFORMATION ABOUT THE DISTRICT

The Alderwood Water and Wastewater District is in southwest Snohomish County and provides water service to approximately 79,429 customer accounts and sanitary sewer services to approximately 41,700 customer accounts. The District also provides wholesale water to other cities with a total population of approximately 97,400 citizens.

An elected, five-member Board of Commissioners governs the District. The Commissioners serve staggered, six-year terms. The Board appoints a General Manager to oversee the District's daily operations as well as its 125 employees. For fiscal year 2014, the District operated on operating revenues of approximately \$74 million.
