
## 2025 WaterSense Toilet Replacement Program

The Alderwood Water & Wastewater District's WasterSense Toilet Replacement Program provides homeowners (single family residence that is a house or condominium) that pay a water bill to Alderwood Water & Wastewater District up to a \$75 rebate for the replacement of one high water flow toilet with a new WaterSense high efficiency toilet, 1.28gpf or less. This form is valid for a toilet purchased and installed in the District's service area through December 31, 2025. Please allow at least 8 weeks for your rebate check.

<ul> <li>The new toilet must bear the EPA WaterSense I labeled toilet. Visit: <u>https://www.epa.gov/watersense/reside</u></li> <li>You must be an Alderwood Water &amp; Wastewate</li> </ul>	label no exceptions. Ask your retailer or plu ential-toilets r District retail customer (i.e. pay your water b	oill to the District).
• The property where the toilets are installed must be a single-family residence (house or condominium located in the Alderwood Water & Wastewater District service area with an account with us).
