AWWD Finance Manager Alexis Dickie provided a summary of the current budget. She stated that for October there were total combined monetary assets just over \$1 million, which is up from the prior report and the net earnings rate for LGIP is a little over 5%. The accounts payable packet was \$416,666.08 and we have spent approximately 74% of the budget to date.
