AGREEMENT FOR INTERIM SEWER SERVICE

BACKGROUND

- 1. AWWD and NUD are neighboring public water and sewer utilities authorized to provide sanitary sewer service to customers located within their respective service boundaries.
- 2. Snohomish County Tax parcels, located within AWWD's service boundaries and its sanitary sewer service area, commonly known as:
 - 129 244th Street Southwest, Bothell, WA 98021
 - 127 244th Street Southwest, Bothell, WA 98021
 - 125 244th Street Southwest, Bothell, WA 98021
 - 119 244th Street Southwest, Bothell, WA 98021
 - 107 244th Street Southwest, Bothell, WA 98021
 - 29 244th Street Southwest, Bothell, WA 98021
 - 21 244th Street Southwest, Bothell, WA 98021
 - 24326 Meridian Avenue South, Bothell, WA 98021,

and legally described collectively as:

Lots 3 thru 8 of the Plat of Clifford Jensen Addition and the following; beginning at the Northeast corner of Lot 7 of the Plat of Clifford Jensen Addition thence N 00° 15' 37" W to the North line of the S1/2, SE 1/4 SW 1/4, SE 1/4 of Section 36 Township 27 Range 4, thence N 89° 12' 59" W to the Northwest corner of the said subdivision, thence S 00° 18' 02" E along the west said subdivision to the Northwest corner of Lot 8 of the Plat of Clifford Jensen, thence S 89° 13' 43" E to the Point of Beginning,

(collectively "Real Properties" and individually by tax parcel "Real Property"), are being developed for residential use. A diagram showing Real Properties is attached and incorporated hereto as Exhibit "A."

- 3. Development of Real Properties will require sanitary sewer service.
- 4. AWWD provides water service to Real Properties, however, AWWD's public sanitary sewer system cannot, at this time, be extended to serve Real Properties.
- 5. NUD's public sanitary sewer system is in proximity to Real Properties and NUD can provide interim sanitary sewer service to Real Properties.

6. Chapter 39.34 of the Revised Code of Washington provides for interlocal cooperation between governmental entities.

AGREEMENT

AWWD agrees that NUD can provide, and NUD agrees to provide, interim sanitary sewer service to Real Properties under the following terms and conditions.

- As a condition of service and prior to connection to NUD's public sanitary sewer system, each Real Property shall pay to NUD all fees and charges NUD imposes as conditions of connection to its system.
- 8. NUD shall provide sanitary sewer service to each Real Property on the same terms and conditions as it provides sanitary sewer service to similar property within NUD's service boundaries and according to NUD's resolutions, rules and regulations.
- AWWD agrees to send NUD an electronic file of the meter readings and usage of each Real Property receiving water service from AWWD within 15 days after each billing for water service.
- 10. Whenever AWWD can provide permanent sanitary sewer service to Real Properties and upon written notice from the AWWD, sewer service accounts for Real Properties shall be transferred to AWWD at AWWD's expense. AWWD shall assume all of NUD's obligations under this agreement and for sanitary sewer service to Real Properties. NUD shall be entitled to retain all connection charges, service fees, and all other fees collected from Real Properties.
- 11. This agreement shall be recorded with the King County Recorder's Office and the Recording Division of Snohomish County Auditor's Office at NUD's expense.
