AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Alderwood Water and Wastewater District from January 1, 2018 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounts receivable – utility billings, adjustments, and collections
- Accounts payable – electronic funds transfers
- Open public meetings minutes – documentation of minutes, executive sessions and special meetings

INFORMATION ABOUT THE DISTRICT

The Alderwood Water & Wastewater District is in southwest Snohomish County with boundaries covering 44 square miles. The District provides water service to approximately 54,300 customer accounts and sanitary sewer services to approximately 41,500 customer accounts. The District also provides water services via wholesale contracts with the cities of Edmonds, Lynnwood, and Mountlake Terrace, Mukilteo Water & Wastewater District, and Silver Lake Water and Sewer District.

An elected, five-member Board of Commissioners governs the District. The Commissioners serve staggered, six-year terms. The Board appoints a General Manager to oversee the District's daily operations. For fiscal year 2018, the District reported operating expenses of approximately \$87.3 million.
